New Addresses for Invoice Receipt

At Tide, we are continuously working to streamline and improve our invoice handling process.

EHF Invoice:

We prefer to receive electronic invoices from our suppliers in the standard Electronic Trading Format (EHF). If it is not possible to send invoices as EHF, invoices can be sent as PDFs. The invoice and attachments must be a single PDF document. Please refer to the table below for the organization numbers for EHF invoices, or alternatively, the email addresses for sending PDF invoices.

Payment Terms:

Tide operates with a minimum of 30 days payment terms unless otherwise agreed. This ensures sufficient time for your invoice to be received, processed, and paid.

Invoice Marking Requirements:

In relation to the requirements for sales documentation according to the Bookkeeping Regulations §§ 5-1-1 to 5-1-8, it is emphasized that the invoice must meet the following requirements:

- The name of the purchaser with a valid reference
- The invoice must be addressed to the correct company name and organization number
- The invoice must include the sender's organization number and bank account number
- The text on the invoice must be clear
